HAVING REGARD to the Decree of the President of the Republic 28.12.2000, n. 445;

HAVING REGARD to Articles 2 and 12 of Ministerial Decree of 9 April 2001, "Equal treatment regarding the right to higher education";

HAVING REGARD to Regulations for Administration, Finance and Accounting, issued by Rectoral decree n. 828 prot.n. 7766 of 14/03/2014 and in particular Articles 75 and 79;

HAVING REGARD TO letter prot. no. 30347/2025 of 07/02/2025 in which Lorenzo Orsenigo, legal representative of the company ICMQ SpA, expressed his intention of donating to the Politecnico di Milano the amount of \notin 2,000.00 to promote study activities in the field of engineering through the award of a degree prize to graduates in the year 2024 in the Laurea Magistrale (equivalent to a Master of Science) in Building Engineering and in Building and Architectural Engineering and in the single-cycle Laurea Magistrale (equivalent to a Master of Science) in Building Engineering, Architecture of the Politecnico di Milano;

HAVING REGARD TO Director Decree no. 2899/2025 Prot. 34703/2025 of 12/02/2025, stating the acceptance of the donation decided by ICMQ SpA;

HEREBY DECREES

The issue of the call for applications for no. **1 "Paride Passerini" year 2025** Laurea Magistrale degree prize.

art. 1

Features of the degree prize and beneficiaries

The laurea magistrale degree prize ($\in 2,000.00$ before tax and inclusive of the taxes owed by the Politecnico di Milano) will be awarded to the best laurea magistrale degree thesis addressing matters related to: "Sustainable building design, construction and production solutions according to consolidated parametric protocols"

The call is open to students who have graduated with a Laurea Magistrale (equivalent to Master of Science) from the Politecnico di Milano:

- 1. in Ingegneria dei Sistemi Edilizi
- 2. in Building and Architectural Engineering
- 3. in Ingegneria Edile Architettura (ciclo unico)



4. during the period from April 2024 to December 2024

The theses may address:

- the conscious and innovative use of materials and/or technological systems;
- the optimization of the building plant system;
- the economic impact of sustainable design solutions, in terms of both planning, execution, management and disposal;
- the analysis of and comparison between reference protocols and the efficacy thereof on sustainability;
- the study and implementation of sustainability certification systems both for buildings and products;
- the analysis and assessment of the technological and economic impact of certifications on the market, both in terms of improvement of construction standards and of the widespread use of sustainability models in construction.

The Fundraising and Alumni Unit will verify whether the requirements have been met using the Politecnico di Milano's digital archive.

It is the applicant's responsibility to ensure that the data present in the Politecnico di Milano's digital archive are correct and current by the deadline of this call for applications.

art. 2 Participation procedures

Candidates are required to submit the application form through the dedicated function available from On-line services <u>http://www.polimi.it/servizionline</u> (Benefits and agreements> Economic benefits) **within 12.00 noon (Italian time) of 21 March 2025.**

Applicants **must attach**, through the specific procedure:

• **the** laurea magistrale **degree thesis in pdf format, maximum 13 MB** or alternatively, if the document exceeds 13 MB, a PDF file containing the link without expiry date to a folder in cloud storage that must contain the thesis in PDF format;

The files must be named in the format Surname-Name-Type of document.pdf (for example Smith-John-Thesis.pdf)

Make sure you check that the link to the folder can actually be used by the Selection Board, that it has no expiry date or access restrictions and that it is not damaged.

Documents must be uploaded to the cloud by the deadline of the above-mentioned competition and must not be changed after this date, under penalty of exclusion from the evaluation



Upon completion of the online application process (status: closed), the application to this call shall be deemed to have been submitted and the applicant shall be understood to have agreed to the contents of the call itself.

It is the applicant's responsibility to check that the process has been completed correctly.

After having completed and submitted the application, the applicant may print a receipt and the application may no longer be altered. The applicant may delete and resubmit the application at any time before the deadline of this call for applications.

Failure to complete the application, the submission of an incomplete application, the submission of inadequate documents or unusable link shall result in the applicant being excluded from the assessment process.

In the case of theses with multiple authors, each co-author that intends to apply for the award must submit an individual application. In this case, all authors must submit identical documentation, as requested in Art. 2.

Should one or more of the co-authors not wish to participate, it shall be left to the applicant author to decide whether to contact them in the event of winning the prize.

art. 3 Judging Panel

The awarding will be decided by a Judging Panel designated after the expiration date of the call by a Decree of the Manager.

In formulating the ranking, the Board shall make a decision on the basis of the attachments uploaded through the appropriate procedure and their relevance and significance to the topics indicated in Art. 1.

In case of an ex-aequo, the Judging Panel may divide the prize among several candidates, provided the conditions referred to in art. 1 of the call are met.

The Judging Panel reserves the right to not award the prize of the Call if the candidates are not considered suitable.

art. 4 General rules

Cumulability: the laurea magistrale degree prize cannot be added to other prizes awarded for the same laurea magistrale degree thesis by Politecnico di Milano.

Renunciation: if the winner renounces the prize, it will be awarded to the next highest ranking applicant in the ranking list.

Award: the winner will be informed of the laurea magistrale degree prize award via an e-mail sent to his/her university e-mail address. No later than 10 days from receiving the e-mail, the winner must sign for acceptance and send the specific forms s/he will find attached to the award e-mail.

The Politecnico di Milano shall award the prize in a single instalment.

Taxation: the prize awarded is subject to the current laws governing the taxation of scholarships. The sum paid as the degree prize is to be treated as income comparable to income from employment for taxation purposes. The tax due by the Politecnico di Milano is IRAP (equal to 8.5% of the value of the degree prize).

INFORMATION PURSUANT TO ARTICLE 13 OF THE EUROPEAN GENERAL DATA PROTECTION REGULATION

Through this document, the Politecnico di Milano (hereinafter also called *Polytechnic*), as Data Controller, with offices located in Piazza Leonardo da Vinci 32, 20133 Milan - General Management - , informs you with regard to the processing of your personal data, in compliance to Regulation (EU) 2016/679 of the European Parliament and Council dated 27 April 2016 on the protection of individuals regarding the processing of personal data and related implementing legislation (hereinafter also called the *Regulations*).

The Data Processor, of the data provided by you, is the Director of the Research, Innovation and Corporate Relations Division.

A. PERSONAL DATA COLLECTED

The personal data collected and processed by the Polytechnic, which regards you, is the following: (a) the data you communicated at the time of registration or enrollment, such as name, surname, date and place of birth, sex, social security number, nationality, address of residence, telephone and IT addresses, qualifications; (b) the data collected at the time of submission of the application, in particular the data relating to your academic career, qualifications achieved, as well as the data to your financial condition.

B. PURPOSE AND METHOD OF PROCESSING

Your personal data may be processed:

to verify eligibility requirements to participate in the competition according to the criteria set out in this announcement and for any other purpose required by law, also with the aim of processing statistical information

In relation to the aforementioned purposes, data processing by the Politecnico di Milano will take place using manual, computerized and electronic tools in a relevant manner and limited to what is necessary with respect to the purposes for which they are processed and, in any case, in order to guarantee the maximum security and confidentiality and, always, in full compliance with the legislation in force. The Politecnico will take all measures to promptly correct inaccurate data in relation to the processing purposes.



With reference to the particular data, the processing will be carried out in a proportionate manner with regard to the aim pursued, while adopting appropriate and specific measures to protect your fundamental rights.

C. COMPULSORY AND NON-COMPULSORY DATA

Providing data, for the purposes referred to in paragraph B. point 1, is mandatory and any refusal to provide such data involves the inadmissibility of the application submitted by the student and the immediate exclusion from the procedure.

D. DATA CIRCULATION AND COMMUNICATION

Your personal data will be passed on to the Polytechnic employees who will be authorized to process this data, or to natural or legal persons who provide consulting services or collaborate with the Polytechnic for the purpose of providing the selection procedures as foreseen by the competition announcement.

Your personal data, also, will be sent to Istituto di Certificazione e Marchio di Qualità per Prodotti e Servizi per le Costruzioni - ICMQ to inform about the result of the call.

E. RETENTION AND POSSIBLE TRANSFER OF PERSONAL DATA

Your personal data will be stored at the Politecnico di Milano. Your data will not be transferred to a third country.

F. PERSONAL DATA PERIOD OF RETENTION

Your personal data will be kept for the time strictly necessary to guarantee access to the right to study benefits, unless the retention of data for a longer period is necessary for archiving purposes in the public interest, for scientific or historical research or for statistical purposes. Should data retention be needed for longer periods, the Polytechnic guarantees compliance with the principle of data minimization pursuant to art. 89, paragraph 1 of the Regulations.

G. YOUR RIGHTS

We would like to remind you that you have the right:

- to obtain information in relation to the ways in which your data is processed and any other information required by art. 15 of the Regulations (*right of access*)

- to obtain the correction of inaccurate personal data concerning you pursuant to art. 16 of the Regulations (*rectification right*)

- to obtain a limitation on the processing of personal data concerning you pursuant to art. 18 of the Regulations (*processing restriction right*);



- to oppose the processing of your personal data in the cases and under the conditions provided for by art. 21 of the Regulations (*right of opposition*)
